Nine Mile Point Unit 2 Extended Power Uprate (EPU) Application

By application dated May 27, 2009, the licensee requested a 15% EPU for Nine Mile Point Unit 2. The application requests NRC approval in 18 months with implementation upon startup from the Spring 2012 refueling outage. NRC's standard review time for an EPU is 12 months after NRC's acceptance of the application. The NRC staff will be conducting an acceptance review of the application.

Electric Power Research Institute (EPRI) - Performance Demonstration Initiatives (PDI) Meetings

On May 27 and 28, 2009, the staff met with representatives of the EPRI-PDI. These meetings are conducted semi annually to discuss EPRI-PDI's implementation of the requirements of the American Society of Mechanical Engineers (ASME) Code for ultrasonic testing (UT) qualifications and other UT issues of mutual interest. The staff aggressively pursued EPRI-PDI for improvements of flaw sizing accuracy and addressing conflicts and omissions of UT ASME Code qualifications. Action items were identified for evaluation, development, and resolution as appropriate. These action items will be topics of discussion at future meetings.

Proposed Rulemaking Pertaining to 10 CFR 50.55a, Codes and Standards

On June 2, 2009, NRC published a *Federal Register* Notice for a proposed rule (74 FR 26303) to amend § 50.55a of Title 10 of the Code of Federal Regulations (10 CFR 50.55a), "Codes and Standards," Incorporate by Reference of American Society of Mechanical Engineers (ASME) Boiler and Pressure Vessel Code Cases. This proposed rule would amend the NRC's regulations to incorporate by reference the latest revisions of the following two previously incorporated regulatory guides (RG) that approve code cases published by ASME, RG 1.84, "Design, Fabrication, and Materials Code Case Acceptability, ASME Section III," Revision 35, and RG 1.147, "Inservice Inspection Code Case Acceptability, ASME Section XI, Division 1," Revision 16. These incorporations by reference would supersede the incorporations by reference of RG 1.84, Revision 34, and RG 1.147, Revisions 15, respectively.

Issuance of the Renewed Operating License For Vogtle Electric Generating Plant, Units 1 and 2

On June 3, 2009, the operating licenses for Vogtle Electric Generating Plant, Units 1 and 2 were renewed authorizing operation for an additional 20 years. The new expiration dates are January 16, 2047 for Unit 1 and February 9, 2049 for Unit 2. The staff completed an on-time review as documented in the safety evaluation report, NUREG 1920 Volumes 1 and 2, issued in April 2009, and the supplemental environmental impact statement, NUREG 1437 Supplement 34, issued December 2008. The issuance of the Vogtle renewed license brings the total number of renewals to 54 reactor units.

HI-STORM 100 Revision 6

A direct final rule entitled, "List of Approved Spent Fuel Storage Casks: HI-STORM 100 Revision 6," was published in the *Federal Register* on June 2, 2009 (74 FR 26285). The companion proposed rule was published at 74 FR 26310. The direct final rule amends Part 72 by revising the Holtec International HI-STORM 100 dry cask storage system listing in 10 CFR 72.214 to include Amendment No. 6 to Certificate of Compliance Number 1014. The cask amendment will allow holders of power reactor operating licenses to load spent fuel in the HI-STORM 100 cask system under revised conditions. The final rule is effective August 17, 2009, unless significant adverse comments are received by July 2, 2009.

NRC, the U.S. Department of Energy (DOE), and the National Institute of Standards and Technology (NIST) Participated in Nuclear Engineering Standards Coordination Collaborative (NESCC) with Representatives of Standards Developing Organizations and Nuclear Industry

On June 1, 2009, NRC staff joined NIST and DOE staff in a meeting with representatives of standards developing organizations and nuclear industry representatives at the NIST campus. The purpose of this meeting was to adopt the charter for the NESCC, a panel established under the sponsorship and coordination of the American National Standard Institute and NIST. The NESCC will provide a cross-stakeholder forum to facilitate and coordinate the timely identification, development, and revision of standards for the design, operation, development, licensing, and deployment of nuclear power plants. Participation in NESCC is open to all stakeholders that represent standards-developing organizations, consortia and other forums, industry, government, and consumers.

Office of the Chief Financial Officer (OCFO) Organizational Assessment

On May 20, 2009, as a result of a competitive acquisition under the General Services Administration (GSA) Federal Supply Schedule, a labor-hour delivery order (DR-09-09-326) was awarded to Ernst and Young, LLC of Washington, D.C., in support of the OCFO with an organizational assessment to provide assistance and expertise for determining OCFO best practices. The period of performance is May 20, 2009, through September 20, 2009, with one option for one additional month. The total value is \$519,607.42, including options.

Potassium Iodine Tablets

On May 28, 2009, as a result of a competitive acquisition, a requirements-type contract (NRC-NRC-09-09-0137) was awarded to Anbex, Inc., of Williamsburg, Virginia, for potassium iodine tablets for the Office of Nuclear Safety and Incident Response. The period of performance is from June 8, 2009, through June 7, 2010. The total value of the contract is \$2,260,800.00.

Technical Assessment of NRC's Audiovisual, Teleconference and Video Distribution Systems

On May 28, 2009, a time and materials contract (NRC-10-09-418) was awarded under the 8(a) provisions of the Small Business Act, to Government Systems, Inc., of Alexandria, Virginia. The contractor will provide a technical assessment of the NRC's audiovisual, video teleconference and video distribution systems. The contract is effective from June 1, 2009, through September 14, 2009. The total value of the contract is \$128,684.00.

Information Technology (IT) Research and Advisory Subscription Services

On May 28, 2009, as a result of a non-competitive acquisition under the GSA Federal Supply Schedule, a fixed-price delivery order, NRC-DR-33-09-385, was awarded to Gartner, Inc., of Arlington, Virginia, for IT research and advisory subscription services. The contractor will provide research and advisory services concerning the latest developments in IT and security and emerging IT trends to the agency's primary information officers. The period of performance is 1 year, from June 1, 2009, through May 31, 2010. The total price of the delivery order is \$179,092.50.

Computer Facilities Operations Support Center

On May 29, 2009, as a result of a competitive negotiated GSA Federal Supply Schedule acquisition, a labor-hour type delivery order, NRC-33-09-302, was awarded to Ruland Associates Inc., of Charles Towne, West Virginia, to provide computer facilities operations support services to the Office of Information Services. The base period of the delivery order is from June 1, 2009, through May 31, 2012, with two 1-year options. The total value of the contract, with options, is \$4,648,752.00.

Incorporation by Reference of Regulatory Guide (RG) 1.84, Revision 35, and Regulatory Guide 1.147, Revision 16, Into 10 CFR 50.55a; Proposed Rule (10 CFR Part 50) (RIN 3150-AI37, NRC-2008-0014)

On June 2, 2009, the NRC published a document (74 FR 26310) in the *Federal Register* proposing to amend its regulations to incorporate by reference the latest revisions of two RGs that would approve new and revised code cases published by the American Society of Mechanical Engineers (ASME). These are RG 1.84, "Design, Fabrication, and Materials Code Case Acceptability, ASME Section III," Revision 35, and RG 1.147, "Inservice Inspection Code Case Acceptability, ASME Section XI, Division 1," Revision 16. This action would allow the use of the code cases listed in these RGs as alternatives to requirements in the ASME Boiler and Pressure Vessel Code regarding the construction and inservice inspection of nuclear power plant components. Concurrent with this action, the NRC is publishing a notice of the issuance and availability of the RGs in the *Federal Register*. The comment period for this proposed rule expires August 17, 2009.

List of Approved Spent Fuel Storage Casks: HI-STORM 100 Revision 6; Direct Final Rule (10 CFR PART 72) (AI60, NRC-2009-0132)

On June 2, 2009, the NRC published a direct final rule (74 FR 26285) in the *Federal Register* that amends its spent fuel storage regulations by revising the Holtec International HI-STORM 100 dry cask storage system listing within the "List of Approved Spent Fuel Storage Casks" to include Amendment No. 6 to Certificate of Compliance (CoC) Number 1014. Amendment No. 6 modifies the CoC to add instrument tube tie rods used for pressurized water reactor 15x15 and 17x17 fuel lattices, for both intact and damaged fuel assemblies, to the approved contents of the MPC-24, MPC-24E, MPC-24EF, MPC-32, and MPC-32F models; it also corrects legacy editorial issues in Appendices A and B Technical Specifications. The direct final rule becomes effective August 17, 2009, unless significant adverse comments are received by July 2, 2009.

On June 2, 2009, the NRC published the companion proposed rule (74 FR 26310) to this direct final rule in the *Federal Register*. The comment period closes July 2, 2009.

Nuclear Information and Records Management Association's (NIRMA) Spring Meeting

On May 27, 2009, staff participated in NIRMA's Regulations and Information Management Business Unit (RIMBU) Spring Meeting. The two main topics of discussion were the final review of NIRMA's Technical Guideline (TG)-15, Management of Electronic Records, and a discussion regarding a NIRMA position paper on Portable Document Format Archive. Other items on the agenda included an NRC update on records related activities and how RIMBU should approach getting endorsement of the updated TGs.

Controlled Unclassified Information (CUI) Council - Working Group

On May 28, 2009, staff participated in a working group of the CUI Council at the National Archives and Records Administration (NARA), which is the Executive Agency for implementing the Federal-wide CUI framework. The purpose of the meeting was to discuss and further develop Version 2 of the strawman for CUI Markings. The chairman of the CUI Council, who is responsible for implementing Federal policy for classified national security information, began the meeting with an explanation of why the marking requirements for CUI are more stringent than most agencies expected. Portion markings will also be required within a CUI document so that paragraphs or sections that contain CUI will be easily identified.

Records Administration Conference

On May 28, 2009, staff attended the 2009 Records Administration Conference, sponsored by NARA, in Washington, DC. Current collaboration tools were explored under the theme, "Collaborating Across Boundaries: Government Records and Social Media." Speakers provided an overview of these technologies, insight into their implications and possibilities for Federal agencies, and case studies from the Internal Revenue Service, the U.S. Geological Survey, the Centers for Disease Control and Prevention, and six intelligence agencies.

2009 Management of Change (MOC) Conference

On May 31 - June 2, 2009, staff attended the 2009 MOC Conference in Norfolk, Virginia, which was sponsored by the American Council for Technology and the Industry Advisory Council. The theme was Charting a Course for Transformation. MOC has brought together government and industry leaders for more than a quarter of a century to share knowledge, collaborate, and develop actionable technology management strategies. The conference focused President Obama's commitment to bringing an integrated approach to IT in government. Both Vivek Kundra, the Federal Chief Information Officer, and Aneesh Chopra, the Federal Chief Technology Officer, spoke.

Office of Management and Budget's Approval of 10 CFR Parts 50 and 52, "Consideration of Aircraft Impacts for New Nuclear Power Reactors"

On June 2, 2009, the Information and Records Services Division received the Office of Management and Budget's approval for 10 CFR Parts 50 and 52, "Consideration of Aircraft Impacts for New Nuclear Power Reactors," Final Rule. The final rule will amend regulations to require applicants for new nuclear power reactors to perform a design-specific assessment of the effects of the impact of a large commercial aircraft.
