The purpose of this modification is to provide incremental funding in the amount of \$17,450, which increases the task order obligated amount from \$14,947 to \$32,397.

Accordingly, the following change is hereby made:

Section A CONSIDERATION AND OBLIGATION—COST PLUS FIXED FEE (JUN 1988), Paragraph (c) is hereby deleted in its entirety and replaced with the following:

(c) The amount presently obligated with respect to this order is \$32,397, of which the sum of \$30,036 represents the estimated reimbursable costs, and of which \$2,361 represent the fixed fee.
