**Trial Advocacy Workshop
Performance Work Statement**

Background: The US Nuclear Regulatory Commission (NRC) is an independent regulatory agency of the federal Government whose mission is to license and regulate the nation's civilian use of nuclear material to ensure adequate protection of public health and safety, promote the common defense and security and protect the environment.

The NRC Office of the General Counsel (OGC) directs matters of law and legal policy, providing opinions, advice, and assistance to the NRC with respect to all of its activities. OGC represents and advises staff offices in all programmatic activities and administrative litigation in connection with licensing and enforcement; represents NRC in administrative proceedings in general commercial law matters such as employment, procurement, and equal employment opportunity, and represents the Commission in courts of appeals proceedings to review Commission orders and rules; and, in cooperation with the Department of Justice, represents the Commission in court proceedings affecting the agency's programs in the Federal District Courts, Courts of Appeals and the Supreme Court.

Most of the litigation work performed by OGC attorneys involves administrative litigation before the NRC's internal tribunal known as the Atomic Safety Licensing Board Panel (ASLBP). The ASLBP adjudicates matters associated with the licensing of nuclear facilities, the use of nuclear material or enforcement of NRC's regulations. Each case before the ASLBP is heard by a Board that is comprised of three administrative judges, generally one judge who is an attorney and two who have professional backgrounds in the scientific/technical fields associated with the agency's regulatory work. The litigation often involves expert testimony in engineering or the physical sciences. Most often, the testimony is filed in advance in written form, followed by oral examination.

Consistent with its litigation responsibilities, the agency has a need to obtain continuing legal education (CLE) advanced training for NRC's professional legal staff in effective and persuasive trial advocacy skills

Objective: The contractor will work with NRC managers and senior attorneys to develop and present a trial advocacy training course. On the scheduled training dates, the contractor, as an independent contractor, will present and provide NRC employees with Trial Advocacy Workshop training, workshop handbook and written course materials.

Scope and Deliverables: Working with managers and senior attorneys in OGC, the contractor will develop and present a course designed to provide OGC attorneys training in conducting administrative hearings, with an emphasis of those elements of trial advocacy that are most important for NRC hearings. Drawing from already existing educational programs models, the contractor should be able to structure a program to address OGC's specific education needs. At a minimum, training modules should include training in the following skills:

1. Preparation and examination of witnesses, with particular focus on scientific/technical experts
2. Motion practice
3. introducing/ admitting evidence and most effectively utilizing documents already in evidence
4. Effective delivery of opening and closing statements
5. Use of PowerPoint as a means of effectively communicating at hearing with the judges and witnesses
6. Appropriate courtroom demeanor and protocol

The contractor will provide case scenarios and situations that will most effectively train participants in the skills identified. It is not required that the workshop simulate an NRC hearing in particular as long as the simulation will provide effective training in the skill areas identified earlier.

The training will be highly participatory where the lawyers will "learn by doing" with opportunities to practice the techniques described and demonstrated by the faculty. It will include real-life settings and experiences and will be followed by a faculty critique that reinforces the effective use of the techniques and recommends ways to enhance skill development. Use of videotaping and other audio/visual tools should be employed to enable participants to view their own performance. The contract does not contemplate videotaping of lectures by contractor instructors, but does contemplate retention by the agency of video recordings of student performance (e.g. presentation of arguments or witness examinations) during a mock hearing/moot court. The contractor shall provide written training material.

The trial advocacy workshop presentation and course materials provided shall generally serve to meet State bar licensing authorities' approved CLE course requirements necessary in obtaining CLE credit for participants. While the NRC or its employees will be individually responsible for obtaining CLE credits from State Authorities, the contractor/ instructor will assist the NRC in documenting the CLE training and when required sending and or certifying on State CLE forms that CLE training was provided by qualified trainers/ instructors under an approved CLE program of instruction.

It is anticipated that an effective litigation training program addressing (at least) the skills identified above will require three to four full training days per training session. The agency expects each training session to be attended by no more than 10 attorneys plus an NRC-designated senior attorney who will supplement the contractor-provided instruction to focus on the litigation environment specific to the NRC. The agency will also provide staff members to serve as witnesses or in other roles needed for purposes of the mock trial or moot court. The contractor will present three training sessions within a period of approximately six months from the start of the contract performance period. The total number of attorneys to be trained under this contract will be no more than 30.

No later than 30 calendar days prior to the scheduled date of the first training session, and in addition to the training workshop development and services, the contractor shall provide loose leaf course materials in a binder. A quantity of 12 course handbooks and/or written course materials shall be provided by the contractor for use in each training session. If the contractor

uses a reference book as part of the training, a copy of the book will be part of the materials provided to each participant.

NRC Headquarters is located at One White Flint North, 11555 Rockville Pike, Rockville, Maryland. The contractor shall present CLE approved Trial Advocacy Workshop training services and provide written course materials on site at NRC Headquarters or in one of the Headquarters satellite buildings located in Rockville or Bethesda, Maryland.

Schedule: NRC managers and senior attorneys will meet with the contractor as soon as possible to begin developing the course. The training workshop shall be provided and presented in June 2009 or at the earliest date and time agreed to by the contractor and the NRC. Each of the training days will begin at approximately 9:00 AM and end at 4:30 PM with appropriate lunch and breaks taken during those hours.

Price/ Costs: The contractor shall provide all course development, training services, workshop presentation and deliverables including course materials and course books at a total fixed price that is stated in the NRC issued purchase order. The purchase order's total fixed price amount includes and covers all costs including the contractor's and its consultant's labor, wages or salary, overhead, benefits, travel, transportation, hotel accommodation, expenses and tips, food and refreshments, package, shipping of course material and binders, licensing fees, lecture fees, profit, and taxes.

Key Contractor Personnel:

a. The proposed contractor's training instructor shall be deemed key contractor personnel and the contractor shall therefore obtain review and approval by the NRC Contracting Officer or the NRC Contracting Officer's Representative prior to assigning or substituting the proposed contractor training instructor.

b. Instructor Qualifications. The training instructor shall possess the following qualifications, experience and skills:

- (1) At least 5 years experience in instructing lawyers on trial advocacy.
- (2) Has been authorized to practice law as a lawyer, or judge or judge's law clerk for at least 5 years and has experience in all aspects of litigation, including oral argument, motion practice, witness preparation and discovery.
- (3) Well recognized as a subject matter expert in trial advocacy training to lawyers, as evidenced by awards, publications, or peer recognition.
- (4) Published or edited articles, books on the topic of trial advocacy
- (5) A copy of the proposed key personnel's resume shall be provided showing that all key individuals meet the requirements.

Government Furnished Equipment and Facilities: A month prior to the scheduled workshop presentation date, the contractor shall list and coordinate with the NRC project representative with respect to the on site room set up, along with the equipment type and compatibility requirements necessary for conducting the workshop. On the morning of the day of the training workshop presentation, the NRC will provide or make available to the contractor at the site of

the NRC with government furnished space, seating, information technology equipment and audio-video equipment that is necessary for conducting the training workshop.

(d) Comptroller General Examination of Record. (1) The Comptroller General of the United States, or an authorized representative of the Comptroller General, shall have access to and right to examine any of the Contractor's directly pertinent records involving transactions related to this contract.

(2) The Contractor shall make available at its offices at all reasonable times the records, materials, and other evidence for examination, audit, or reproduction, until 3 years after final payment under this contract or for any shorter period specified in FAR Subpart 4.7, Contractor Records Retention, of the other clauses of this contract. If this contract is completely or partially terminated, the records relating to the work terminated shall be made available for 3 years after any resulting final termination settlement. (a) Purpose. The primary purpose of this clause is to aid in ensuring that the contractor:

(1) Is not placed in a conflicting role because of current or planned interests (financial, contractual, organizational, or otherwise) which relate to the work under this contract; and

(2) Does not obtain an unfair competitive advantage over other parties by virtue of its performance of this contract.

(b) Scope. The restrictions described apply to performance or participation by the contractor, as defined in 48 CFR 2009.570-2 in the activities covered by this clause.

(c) Work for others.

(1) Notwithstanding any other provision of this contract, during the term of this contract, the contractor agrees to forego entering into consulting or other contractual arrangements with any firm or organization the result of which may give rise to a conflict of interest with respect to the work being performed under this contract. The contractor shall ensure that all employees under this contract abide by the provision of this clause. If the contractor has reason to believe, with respect to itself or any employee, that any proposed consultant or other contractual arrangement with any firm or organization may involve a potential conflict of interest, the contractor shall obtain the written approval of the contracting officer before the execution of such contractual arrangement.

(2) The contractor may not represent, assist, or otherwise support an NRC licensee or applicant undergoing an NRC audit, inspection, or review where the activities that are the subject of the audit, inspection, or review are the same as or substantially similar to the services within the scope of this contract (or task order as appropriate) except where the NRC licensee or applicant requires the contractor's support to explain or defend the contractor's prior work for the utility or other entity which NRC questions.

(3) When the contractor performs work for the NRC under this contract at any NRC licensee or applicant site, the contractor shall neither solicit nor perform work in the same or similar technical area for that licensee or applicant organization for a period commencing with the award of the task order or beginning of work on the site (if not a task order contract) and ending one year after completion of all work under the associated task order, or last time at the site (if not a task order contract).

(4) When the contractor performs work for the NRC under this contract at any NRC licensee or applicant site,

(i) The contractor may not solicit work at that site for that licensee or applicant during the period of performance of the task order or the contract, as appropriate.

(ii) The contractor may not perform work at that site for that licensee or applicant during the period of performance of the task order or the contract, as appropriate, and for one year thereafter.

(iii) Notwithstanding the foregoing, the contracting officer may authorize the contractor to solicit or perform this type of work (except work in the same or similar technical area) if the contracting officer determines that the situation will not pose a potential for technical bias or unfair competitive advantage.

(d) Disclosure after award.

(1) The contractor warrants that to the best of its knowledge and belief, and except as otherwise set forth in this contract, that it does not have any organizational conflicts of interest as defined in 48 CFR 2009.570-2.

(2) The contractor agrees that if, after award, it discovers organizational conflicts of interest with respect to this contract, it shall make an immediate and full disclosure in writing to the contracting officer. This statement must include a description of the action which the contractor has taken or proposes to take to avoid or mitigate

such conflicts. The NRC may, however, terminate the contract if termination is in the best interest of the Government.

(3) It is recognized that the scope of work of a task-order-type contract necessarily encompasses a broad spectrum of activities. Consequently, if this is a task-order-type contract, the contractor agrees that it will disclose all proposed new work involving NRC licensees or applicants which comes within the scope of work of the underlying contract. Further, if this contract involves work at a licensee or applicant site, the contractor agrees to exercise diligence to discover and disclose any new work at that licensee or applicant site. This disclosure must be made before the submission of a bid or proposal to the utility or other regulated entity and must be received by the NRC at least 15 days before the proposed award date in any event, unless a written justification demonstrating urgency and due diligence to discover and disclose is provided by the contractor and approved by the contracting officer. The disclosure must include the statement of work, the dollar value of the proposed contract, and any other documents that are needed to fully describe the proposed work for the regulated utility or other regulated entity. NRC may deny approval of the disclosed work only when the NRC has issued a task order which includes the technical area and, if site-specific, the site, or has plans to issue a task order which includes the technical area and, if site-specific, the site, or when the work violates paragraphs (c)(2), (c)(3) or (c)(4) of this section.

(e) Access to and use of information.

(1) If in the performance of this contract, the contractor obtains access to information, such as NRC plans, policies, reports, studies, financial plans, internal data protected by the Privacy Act of 1974 (5 U.S.C. Section 552a (1988)), or the Freedom of Information Act (5 U.S.C. Section 552 (1986)), the contractor agrees not to:

(i) Use this information for any private purpose until the information has been released to the public;

(ii) Compete for work for the Commission based on the information for a period of six months after either the completion of this contract or the release of the information to the public, whichever is first;

(iii) Submit an unsolicited proposal to the Government based on the information until one year after the release of the information to the public; or

(iv) Release the information without prior written approval by the contracting officer unless the information has previously been released to the public by the NRC.

(2) In addition, the contractor agrees that, to the extent it receives or is given access to proprietary data, data protected by the Privacy Act of 1974 (5 U.S.C. Section 552a (1988)), or the Freedom of Information Act (5 U.S.C. Section 552 (1986)), or other confidential or privileged technical, business, or financial information under this contract, the contractor shall treat the information in accordance with restrictions placed on use of the information.

(3) Subject to patent and security provisions of this contract, the contractor shall have the right to use technical data it produces under this contract for private purposes provided that all requirements of this contract have been met.

(f) Subcontracts. Except as provided in 48 CFR 2009.570-2, the contractor shall include this clause, including this paragraph, in subcontracts of any tier. The terms contract, contractor, and contracting officer, must be appropriately modified to preserve the Government's rights.

(g) Remedies. For breach of any of the above restrictions, or for intentional nondisclosure or misrepresentation of any relevant interest required to be disclosed concerning this contract or for such erroneous representations that necessarily imply bad faith, the Government may terminate the contract for default, disqualify the contractor from subsequent contractual efforts, and pursue other remedies permitted by law or this contract.

(h) Waiver. A request for waiver under this clause must be directed in writing to the contracting officer in accordance with the procedures outlined in 48 CFR 2009.570-9.

(i) Follow-on effort. The contractor shall be ineligible to participate in NRC contracts, subcontracts, or proposals therefor (solicited or unsolicited), which stem directly from the contractor's performance of work under this contract. Furthermore, unless so directed in writing by the contracting officer, the contractor may not perform any technical consulting or management support services work or evaluation activities under this contract on any of its products or services or the products or services of another firm if the contractor has been substantially involved in the development or marketing of the products or services.

(1) If the contractor, under this contract, prepares a complete or essentially complete statement of work or specifications, the contractor is not eligible to perform or participate in the initial contractual effort which is based on the statement of work or specifications. The contractor may not incorporate its products or services in the statement of work or specifications unless so directed in writing by the contracting officer, in which case, the restrictions in this paragraph do not apply.

(2) Nothing in this paragraph precludes the contractor from offering or selling its standard commercial items to the Government.

(b) Performance of the work under this contract is subject to the technical direction of the NRC project officer. The term "technical direction" is defined to include the following:

(1) Technical direction to the contractor which shifts work emphasis between areas of work or tasks, authorizes travel which was unanticipated in the Schedule (i.e., travel not contemplated in the Statement of Work (SOW) or changes to specific travel identified in the SOW), fills in details, or otherwise serves to accomplish the contractual SOW.

(2) Provide advice and guidance to the contractor in the preparation of drawings, specifications, or technical portions of the work description.

(3) Review and, where required by the contract, approval of technical reports, drawings, specifications, and technical information to be delivered by the contractor to the Government under the contract.

(c) Technical direction must be within the general statement of work stated in the contract. The project officer does not have the authority to and may not issue any technical direction which:

- (1) Constitutes an assignment of work outside the general scope of the contract.
 - (2) Constitutes a change as defined in the "Changes" clause of this contract.
 - (3) In any way causes an increase or decrease in the total estimated contract cost, the fixed fee, if any, or the time required for contract performance.
 - (4) Changes any of the expressed terms, conditions, or specifications of the contract.
 - (5) Terminates the contract, settles any claim or dispute arising under the contract, or issues any unilateral directive whatever.
- (d) All technical directions must be issued in writing by the project officer or must be confirmed by the project officer in writing within ten (10) working days after verbal issuance. A copy of the written direction must be furnished to the contracting officer. A copy of NRC Form 445, Request for Approval of Official Foreign Travel, which has received final approval from the NRC must be furnished to the contracting officer.
- (e) The contractor shall proceed promptly with the performance of technical directions duly issued by the project officer in the manner prescribed by this clause and within the project officer's authority under the provisions of this clause.
- (f) If, in the opinion of the contractor, any instruction or direction issued by the project officer is within one of the categories as defined in paragraph (c) of this section, the contractor may not proceed but shall notify the contracting officer in writing within five (5) working days after the receipt of any instruction or direction and shall request the contracting officer to modify the contract accordingly. Upon receiving the notification from the contractor, the contracting officer shall issue an appropriate contract modification or advise the contractor in writing that, in the contracting officer's opinion, the technical direction is within the scope of this article and does not constitute a change under the "Changes" clause.
- (g) Any unauthorized commitment or direction issued by the project officer may result in an unnecessary delay in the contractor's performance and may even result in the contractor expending funds for unallowable costs under the contract.
- (h) A failure of the parties to agree upon the nature of the instruction or direction or upon the contract action to be taken with respect thereto is subject to 52.233-1 -Disputes.
- (i) In addition to providing technical direction as defined in paragraph (b) of the section, the project officer shall:
- (1) Monitor the contractor's technical progress, including surveillance and assessment of performance, and recommend to the contracting officer changes in requirements.
 - (2) Assist the contractor in the resolution of technical problems encountered during performance.
 - (3) Review all costs requested for reimbursement by the contractor and submit to the contracting officer recommendations for approval, disapproval, or suspension of payment for supplies and services required under this contract.
 - (4) Assist the contractor in obtaining the badges for the contractor personnel.
 - (5) Immediately notify the Security Branch, Division of Facilities and Security (SB/DFS) (via e-mail) when a contractor employee no longer requires access authorization and return of any NRC issued badge to SB/DFS within three days after their termination.

(6) Ensure that all contractor employees that require access to classified Restricted Data or National Security Information or matter, access to sensitive unclassified information (Safeguards, Official Use Only, and Proprietary information) access to sensitive IT systems or data, unescorted access to NRC controlled buildings/space, or unescorted access to protected and vital areas of nuclear power plants receive approval of SB/DFS prior to access in accordance with Management Directive and Handbook 12.3.

(7) For contracts for the design, development, maintenance or operation of Privacy Act Systems of Records, obtain from the contractor as part of closeout procedures, written certification that the contractor has returned to NRC, transferred to the successor contractor, or destroyed at the end of the contract in accordance with instructions provided by the NRC Systems Manager for Privacy Act Systems of Records, all records (electronic or paper) which were created, compiled, obtained or maintained under the contract.

(b) If one or more of the key personnel, for whatever reason, becomes, or is expected to become, unavailable for work under this contract for a continuous period exceeding 30 work days, or is expected to devote substantially less effort to the work than indicated in the proposal or initially anticipated, the contractor shall immediately notify the contracting officer and shall, subject to the concurrence of the contracting officer, promptly replace the personnel with personnel of at least substantially equal ability and qualifications.

(c) Each request for approval of substitutions must be in writing and contain a detailed explanation of the circumstances necessitating the proposed substitutions. The request must also contain a complete resume for the proposed substitute and other information requested or needed by the contracting officer to evaluate the proposed substitution. The contracting officer and the project officer shall evaluate the contractor's request and the contracting officer shall promptly notify the contractor of his or her decision in writing.

(d) If the contracting officer determines that suitable and timely replacement of key personnel who have been reassigned, terminated, or have otherwise become unavailable for the contract work is not reasonably forthcoming, or that the resultant reduction of productive effort would be so substantial as to impair the successful completion of the contract or the service order, the contract may be terminated by the contracting officer for default or for the convenience of the Government, as appropriate. If the contracting officer finds the contractor at fault for the condition, the contract price or fixed fee may be equitably adjusted downward to compensate the Government for any resultant delay, loss, or damage.

(a) The U.S. Nuclear Regulatory Commission (NRC) contractor and its subcontractor are subject to the Whistleblower Employee Protection public law provisions as codified at 42 U.S.C. 5851.
