COMPLAINANT'S REPLY TO RESPONDENT FLORIDA POWER & LIGHT COMPANY'S SECOND NOTICE OF SUPPLEMENTAL AUTHORITY

On May 28, 2009, Respondent, Florida Power and Light
Company (FPL) submitted Respondent Florida Power & Light
Company's Second Notice of Supplemental Authority (Notice) in
the above-captioned matter. For the reasons stated below, the
Administrative Review Board (ARB) should DENY FPL's Notice
accordingly:

First, FPL makes reference to an Administrative Law Judge (ALJ) Order to Show Cause in ALJ No. 2009-ERA-006 [sic] and suggests to the ARB, without any apparent explanation, that the ALJ's order is somehow connected to the instant action? Notably, Complainants in ALJ No. 2009-ERA-00006 amply and timely responded to the ALJ's order in ALJ No. 2009-ERA-00006; however,

the presiding ALJ in that particular ERA case has yet to issue a ruling. In any event, despite the ALJ's recommended decision in ALJ No. 2009-ERA-00006, the ARB should not consider the same because it is not a final agency action but merely a recommended decision which has yet to be made by the ALJ. Thus, the ARB should deny FPL's Notice to the extent that FPL requests consideration of a non-binding anticipated and recommended adjudication.

Next, FPL suggests that the ARB should consider a preliminarily decision by the Occupational Safety and Health Administration (OSHA) in OSHA No. 1050-04-09-038, but here again, the decision rendered by OSHA is not a final agency action and has been appealed by the undersigned. Thus, the ARB should deny FPL's Notice to the extent that FPL requests consideration of a non-binding adjudication.

Next, FPL suggests that the ARB should consider the preliminary notice of investigation by OSHA in OSHA No. 4-1050-09-052, but here again, the decision rendered by OSHA is not a final agency action and is presently under investigation by OSHA. Thus, the ARB should deny FPL's Notice to the extent that FPL requests consideration an ongoing OSHA agency action.

Finally, the ARB should reject and deny FPL's Notice because once again, Respondent has willfully and knowingly violated the dictates of the ARB in filing a document outside the parameters defined by the ARB. Specifically, FPL's Notice contains a footnote with a font size that is not in compliance with the ARB's pleading requirements in size and type. Such arrogance and defiance by FPL cannot be simply dismissed or ignored by the ARB as the ARB has in the past sanctioned pro se complainants for such egregious conduct. Here, FPL's polished and seasoned and professional attorneys make a mockery of the ARB's dictates in this respect for all the public to see.

CONCLUSION

FOR ALL THE FOREGOING REASONS, and as a matter of law, the ARB should reject and deny FPL's Notice accordingly and consider FPL's continued conduct in filing such frivolous actions before the ARB to be "proof positive" of FPL's continuing violation of the ERA in adverse actions taken against the undersigned since FPL was found by the U.S. Department of Labor (DOL) Secretary of Labor (SOL) to have illegally violated the ERA in reprisal for the undersigned's raising nuclear safety concerns directly to the U.S. Nuclear Regulatory Commission (NRC) in 1988 regarding

operations at the FPL Turkey Point Nuclear Plant. See, ALJ No. 89-ERA-07/17, Decision and Remand Order, Sec'y (June 3, 1994). Notably, on remand, the FPL senior vice president, John Odom (Odom) who made the decision to fire Saporito, stated in open court under oath that (1) [h]e would not have fired Saporito if Saporito had not raised any nuclear safety concerns; (2) [h]e made the decision to fire Saporito before Saporito was sent to be examined by the FPL company doctor; and (3) [h]e required Saporito to holdover on November 30, 1998 to ask Saporito about his safety concerns. Although the ARB issued a Final Decision in that case in favor of FPL, the matter is currently before the Office of the President of the United States for reconsideration by the U.S. Supreme Court.
