Dear Administrative Judges:

In its Order dated January 8, 2009, the Atomic Safety and Licensing Board ("Board") directed the NRC staff ("Staff"), commencing on January 15, 2009, to tender each month "a short report advising as to whether the estimated dates for issuance of the final [Safety Evaluation Report ('SER')] (predicted for summer/fall of 2009) and final [environmental review document] (predicted for December of 2009) have changed or become more definitive."¹ Due to delays in receiving responses to Staff's requests for additional information, the Staff's estimated date for the issuance of the final environmental review document is now February 2010. The Staff expect the issuance of the SER in December 2009.

In keeping with the Board's mandate, the Staff will tender its next monthly status report by July 16, 2009.
