

DESCRIPTION OF MODIFICATION The purpose of Modification No. 2 is to (1) Exercise Option Year Three in accordance with Federal Acquisition Regulation Subpart 52.217-9, "Option to Extend the Term of the Contract," to extend the term of the Interagency Agreement through June 18, 2010; and (2) to obligate incremental funding in the amount of \$125,000, thereby increasing the obligation and ceiling amounts from \$375,000 to \$500,000. Accordingly, the following changes are hereby made: Under Article III - Period of Performance, the paragraph is deleted in its entirety and substituted with the following in lieu thereof: "The period of performance of this agreement shall be from June 19, 2009 - June 18, 2010. The Scope of Work, as set forth in Article I - Scope of Work, and period of performance may be increased as mutually agreed to by both parties by the NRC Contracting Officer's issuance of a modification to this Agreement.
