 On January 21, Region I issued inspection report 50-219/2008007 for the Oyster Creek (OC) license renewal follow-up inspection. The inspection was performed using IP 71003 "Post-Approval Site Inspection for License Renewal," as a prudent measure, absent a final NRC decision on license renewal. The inspection observed OC license renewal activities during the last refueling outage prior to entering the period of extended operation on April 9, 2009.
