
This letter and the enclosed NRC Form 591M refer to the inspection conducted on April 13, 2009, at your facility in Idaho Falls, Idaho, with continued in-office review through May 29, 2009. This inspection was an examination of activities conducted under the authority of Byproduct Materials License 11-27727-01 as they relate to the Commission's rules and regulations and with the conditions of the license. The inspection consisted of a selected examination of procedures and representative records and interviews with personnel. At the conclusion of the onsite inspection, a preliminary exit briefing was conducted with your area radiation safety specialist for the Idaho Falls, Idaho office to discuss the inspection findings. A final exit briefing was conducted telephonically with you on June 16, 2009.

Within the scope of this inspection, no violations were identified; therefore, no response to this letter or the enclosed NRC Form 591M is required. Although this inspection reviewed portions of your corrective actions associated with enforcement action (EA) No. 08-237, you will be advised by separate correspondence of the NRC's final review of this matter.
