

The purpose of this modification is provide incremental funding in the amount of \$78,888.00 thereby increasing the total obligations from \$50,000.00 to \$128,888.00. Accordingly the contract is modified as follows:
"The amount obligated by the Government with respect to this task order is \$128,888.00, of which \$121,848.00 represents the estimated reimbursable costs and the amount of \$7,041.00 represents the fixed fee."
