Dear Ms. Vielti-Cook:

I have been in contact with Congressman McHugh in regards to the Per Diem Rate in the City of Oswego. It is our request that as a representative of the USNRC, that you contact the GSA to acquire a special review for the establishment of a new Non-Standard Area in the City of Oswego, NY 13126.

The standard CONUS rate of \$70 falls well below the daily rates in Oswego. The acquisition of this review would be advantageous to the NRC as the average daily rates of the Best Western Hotel and the Econo Lodge Hotel are \$117 and \$89 respectfully. These two hotels will not honor the \$70 rate and as a result the NRC is forced to pay extra expenses each time your employees travel to Oswego.
