## Subject: Responses to DSS-CD TRACG LTR RAIs

In Reference 1, GE issued Licensing Topical Report NEDE-33147P, *DSS-CD TRACG Application*, February 2004. During a series of phone calls with GE, the NRC staff, requested additional information (RAI) to support their review of the subject LTR. GE 's response to each of these requests is provided herein..

During the series of phone calls, GE discussed its proposed response to each of these RAIs. Please note that the final responses to a number of these RAIs have changed from the initial proposed response. However, these revised responses have not altered the conclusion of the responses.

Many of the responses provided in Enclosures 2 and the information provided in the compact disk in Enclosure 3 contain proprietary information as defined in 10CFR2.390. The affidavit contained in Enclosure 4 identifies that the information contained in Enclosures 2 and the compact disk of Enclosure 3 has been handled and classified as proprietary to GE. GE hereby requests that the proprietary information Enclosures 2 and 3 be withheld from public disclosure in accordance with the provisions of 10 CFR 2.390 and 9.17.
