


The purpose of this modification is to increase the maximum ordering limitation (MOL) by \$66,346 from \$449,746 to \$516,092.

Accordingly, the following change is hereby made:

1. Section B.3 A CONSIDERATION AND OBLIGATION—TASK ORDERS (AUG 1989) ALTERNATE 1 (JUN 1991) , Paragraph (A) is hereby deleted in its entirety and replaced with the following:
 - (a) The Maximum Ordering Limitation (MOL) for precuts and services ordered, delivered and accepted under this contract is \$516,092. The Contracting Officer any place orders with the contract during the contract period provided the aggregate amount of such orders does not exceed the MOL.
