Please Expedite Licensing Action

Dear License Reviewer:

Please amend the above referenced material license to reflect the following modifications:

1. Amend to add a separate line item authorization for the following radioactive materials:

Thallium-201 with a maximum possession limit of 1.0 Curie.
Indium-111 with a maximum possession limit of 250 millicuries.
Gallium-67 with a maximum possession limit of 250 millicuries.
Iodine-123 with a maximum possession limit of 250 millicuries.
Fluorine-18 with a maximum possession limit of 1.0 Curie.

Mallinckrodt requests these materials in any chemical and/or physical form for the preparation and distribution of radioactive drugs to authorized recipients in accordance with 10 CFR 32.72.

This request is in response to the expanded definition of byproduct material in the federal Atomic Energy Act and the regulation of NARM material to the NRC from the states.

All other items relating to our established Radiation Safety Program remain unchanged at this time.

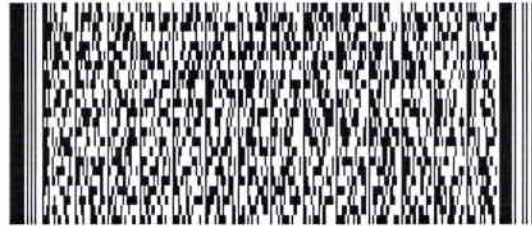

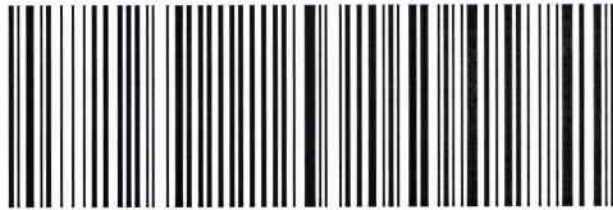
