Dear Sirs:

We propose to change the name on the stated license from Roche Diagnostics Corporation to Roche Diagnostics *Operations, Inc.* The background for this change is as follows:

1. **Description of Transaction:** The parent company of Roche Diagnostics Corporation is Roche Holdings, Inc. In the normal course of business it was decided that certain operations of Roche Diagnostics Corporation (RDC), including administration of licensed activities, should be organized under a new legal entity, Roche Diagnostics Operations, Inc. (RDO). The parent company of both entities remains the same (Roche Holdings Inc.) and the decision to form RDO did not result in a change to personnel or management practices pertaining to licensed activities, nor any change to licensee contacts or contact information.
2. **Changes of Personnel:** There have been no changes to the radiation safety officer, or personnel listed on the license, as a result of the decision to form RDO.
3. **Changes of Location, Equipment and Procedures:** There have been no changes of location, equipment, procedures or administrative control of the licensed program.
4. **Surveillance Records:** There have been no changes to surveillance activities. Surveillance activities continue as before and as required by the license and regulatory requirements. Records remain on file in the same physical location and under control of the same personnel.
5. **Decommissioning and Related Records Transfers:** Operations are ongoing as before with no change in operational footprint, no need for physical transfer of
