References 1 and 2 stated that responses to RAIs 54, 55, 59, 75 (Question 09.05.01-5) and 98 would be provided by June 26, 2009. UniStar Nuclear Energy is currently performing a comprehensive evaluation and overall organizational analysis that provides the bases for these responses.
