The purpose of this modification is provide incremental funding in the amount of \$20,000.00 thereby increasing the total obligations from \$144,500.00 to \$164,500.00. Accordingly the contract is modified as follows:

"The amount obligated by the Government with respect to this task order is \$164,500.00, of which \$157,258.00 represents the estimated reimbursable costs and the amount of \$7,242.00 represents the fixed fee."
