The purpose of this modification is to:

Exercise Option Year 1, thereby increasing the total estimated (ceiling) amount of the contract by \$1,920,156.00, from \$1,403,874.00 to \$3,324,030.00.

Accordingly, the following changes are hereby made to the contract:

1. Section B.3 CONSIDERATION AND OBLIGATION – TASK ORDERS (AUG 1989) ALTERNATE 1 (JUN 1991), paragraphs (a) is revised to read as follows:

(a) The Maximum Ordering Limitation (MOL) for products and services ordered, delivered and accepted under this contract is \$3,324,030.00. The Contracting Officer may place orders with the contractor during the contract period provided the aggregate amount of such orders does not exceed the MOL.

2. Section F.6, DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 4 (JUN 1988), is revised to read as follows:

"The contract shall commence on August 24, 2006 and will expire on August 23, 2008. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 – Ordering.) The term of this contract may be extended at the option of the Government for an additional 1-year option."

All other terms and conditions remain the same.

This modification does not obligate any additional funds.
