The purpose of this modification is to (1) increase the task order ceiling, (2) revise the price schedule, and (3) add incremental funding, as follows:

1. Increase the ceiling of this task order by \$219,999.70, from \$399,774.04 to \$619,773.74.
2. Replace the existing price schedule with the attached revised price schedule, dated May 12, 2009, listing labor categories, hourly rates, and estimated labor hours, for a total estimated ceiling amount of \$619,773.74.
3. Add incremental funding in the amount of \$219,999.70, thereby increasing the obligated amount from \$399,774.04 to \$619,773.74, and fully funding this task order.
