Desc: I am requesting information on any radioactive materials licenses held by various owners or operators of the former Nuodex Corporation site located on Industrial Avenue in Fords NJ. Known license numbers include Nuclear Regulatory Commission License Number SUB-00466 (retired) and another license numbered R.114 The R.114 license may have been issued by the Atomic Energy Commission on April 19, 1956. I believe the NRC license was terminated in 1973 when the site was owned or operated by Tenneco Chemicals Inc - also known as Heyden Chemical Corp.

Specifically, I am requesting: 1) copies of the listed radioactive materials licenses and all amendments, 2) all NRC inspection reports associated with these licenses, and 3) all correspondence, reports and plans associated with these licenses. It is anticipated that some of these records may be found in historical Atomic Energy Commission files.

Examples of documents expected include, but are not limited to: 1) A legible copy of NRC License No SUB-004, 2) US NRC Regulatory Commission Region 1 Inspection Report No. 040-1266/97-001, 3) a letter dated Oct. 19, 1997 from Dr. Ronald Bellamy to Mr. Roger Towe regarding inspection No. 040-01266/97-003.
