The purpose of this modification is provide incremental funding in the amount of \$29,889.00 thereby increasing the total obligations from \$100,000.00 to \$129,889.00. Accordingly the contract is modified as follows:

"The amount obligated by the Government with respect to this task order is \$129,889.00, of which \$123,972.00 represents the estimated reimbursable costs and the amount of \$5,918.00 represents the fixed fee."
