| Satisfactory Findings: | | | |
| Itasca Consulting Group, Inc., was a subcontractor for CNWRA up through the mid–1990's. In late 2008, CNWRA requested that Itasca retain any records relating to the work for CNWRA as part of the legal hold. Itasca decided to return the records to CNWRA, which was accomplished in late March 2009. Staff organized the records from Itasca according to their eventual disposition. The documents sent to CNWRA included (i) copies of documents (including CNWRA procedures and reports) already captured in ELF, – these may be discarded (ii) business/financial/contract-related documents not relevant to Itasca's technical support to CNWRA – these should be discarded by shredding to avoid problems with proprietary information, (iii) working papers, notes, etc., that were not otherwise captured in ELF – these have been processed in ELF as correspondence documents, (iv) several computer disks containing what appeared to be computer runs – these are considered to be quality assurance records and have been processed into ELF as such. | | | |
