Interestingly enough, Rich continues to say that he believes there is no active (on-going) drywell shell corrosion, but he also seems worried that Exelon's monitoring of the drywell may be insufficient. Ron Zak agrees that a 1/4 inch diameter of rust has no impact on the structural integrity of the drywell, but still seems to believe the existing coating is not acceptable. Both Rich and Ron think AmerGen should be REQUIRED to do a 100% coating inspection every outage.
