The purpose of this modification is provide incremental funding in the amount of \$40,610.00 thereby increasing the total obligations from \$127,000.00 to \$167,610.00. Accordingly the contract is modified as follows:

"The amount obligated by the Government with respect to this task order is \$167,610.00, of which \$160,495.00 represents the estimated reimbursable costs and the amount of \$7,115.00 represents the fixed fee."
