The purpose of this modification is to increase the obligated amount by \$5,000 from \$55,000 to \$60,000. Accordingly, paragraph (b) of section A.2 entitled: "Consideration and Obligation - Labor Hour Orders" is revised to read as follows:

"(b) The amount currently obligated by the government with respect to this contract is \$60,000. The contractor shall not exceed this obligated amount at any time."
