

- (2) The amount presently obligated with respect to this order is **\$13,246,058.23**. The Contractor shall not be obligated to incur costs above this ceiling/obligated amount unless and until the Contracting Officer shall increase the amount obligated. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk.

This modification obligates **\$379,816** in FY'09 funds.

All other terms and conditions remain unchanged.
