Dear Mr. Crawford:

Enclosed is Amendment No. 103 to your NRC Material License No. 24-00513-32 in accordance with your request. Please note that the changes made to your license are printed in **bold font**.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

Please note that I adjusted the last Condition of your license to include documents pertaining to your Increased Controls and Fingerprinting Orders responses. I also changed Subitem No. 7.V. to read "Sealed Source," instead of repeating "Americium-241" again, which was incorrect. And I adjusted License Condition No. 18 to refer to Condition No. "30" instead of "32.)

I noted the following potential discrepancies in your license. Please evaluate these issues and advise me as to whether an amendment request is appropriate to address them and correct / clarify the license:

- 1. Subitem Nos. 6. through 9.S. appears to be duplicative, as Subitem Nos. 6. through 9.E. is already on the license.**
- 2. Subitem Nos. 6. through 9. EE appears to be duplicative, as Subitem Nos. 6. through 9.B. is already on the license.**
- 3. Is it correct that Subitem Nos. 6. through 9.DD. is authorized for "Research and development...?"**

Please provide this information within 60 days of the date of this letter, in writing, addressed to my attention and reference it as "additional information to control no. 318072."
