This modification specifically changes these sections of the task order:

Page 2, paragraphs 2 and 3 are hereby modified as follows:

Task Order No. 11 shall be in effect from April 1, 2008 through March 13, 2009 with a cost ceiling of \$64,808.91. The amount of \$61,722.77 represents the estimated reimbursable costs, and the amount of \$3,086.14 represents the fixed fee.
