Dear Mr. Null:

We are writing on behalf of our client, HCA, Inc., to notify you of a corporate reorganization of certain subsidiaries of HCA, Inc. (the "Reorganization"). As a result of the Reorganization, the direct owner of Centerpoint Medical Center of Independence, LLC (i.e., the legal entity through which Centerpoint Medical Center (the "Hospital") is operated) will change. We expect the Reorganization to occur effective as of 11:59 pm on June 30, 2009.

The Hospital holds a Registration of Radioactive Materials with the Nuclear Regulatory Commission ("NRC"). The Reorganization will not change the legal entity through which the Hospital is operated (i.e., Centerpoint Medical Center of Independence, LLC) or the Hospital's ultimate parent (i.e., HCA, Inc.). The Reorganization will only result in a change of the owner of the entity through which the Hospital is operated. Attached is a diagram showing ownership of the Hospital before and after the Reorganization. Such diagram demonstrates that the direct controller and ultimate indirect controller of the Hospital remain unchanged. The Reorganization will not result in any change in the operation of or the management staff of the Hospital, nor will the location, facilities, equipment or procedures change. In addition, the Hospital's taxpayer identification number, officers/board of directors and personnel will not change as a result of the Reorganization. The Reorganization also will not result in a change in the status of the surveillance program. The Hospital will continue to hold all records concerning its Registration of Radioactive Materials, and will continue to abide by all of its current constraints,


