SUBJECT: SUMMARY OF JUNE 25, 2009, CATEGORY 2 MEETING REGARDING
THE NATIONAL FIRE PROTECTION ASSOCIATION STANDARD 805
FREQUENTLY ASKED QUESTION PROCESS

On June 25, 2009, the U.S. Nuclear Regulatory Commission (NRC) staff held a meeting with stakeholders and the public to discuss Frequently Asked Questions (FAQs) at plants that are adopting National Fire Protection Association (NFPA) Standard 805. Licensees introduced and discussed a revised version of FAQ 07-0035, and technical agreement was reached on this FAQ. Licensees briefly discussed a new FAQ related to the use of the NFPA 805 change evaluation process to implement new shutdown strategies. The new FAQ, 09-0057, was submitted shortly after the meeting. Licensees and the NRC staff discussed the currently open FAQs. The participants determined that both industry stakeholders and the NRC staff needed to continue to work on the remaining open FAQs.

Participants discussed publicly available NRC draft interim positions on several FAQs related to NUREG/CR-6850, and licensees were given the opportunity to ask clarifying questions. Licensees stated that they expected to have minimal comments on the draft interim positions.

NRC staff presented updated schedules for the review of the pilot plants' license amendment requests and development of NFPA 805 infrastructure.

Participants agreed that the next FAQ meeting would take place on July 23, 2009.
