Subject: Notes From 7-17-09 Conference Call on Detroit Edison's 6-19-09 RAI Response Submittal

Randy,

This email summarizes the discussions during our conference call on July 17, 2009, to discuss the U.S. Nuclear Regulatory Commission's (NRC's) specific comments on Detroit Edison's June 19, 2009 Requests for Additional Information (RAI) response submittal, as well as general comments and issues pertaining to Detroit Edison's June 19 submittal and all future RAI responses. The general comments and issues were discussed first. Also summarized are the action items for Detroit Edison from the call. If you have any comments on, or suggested changes to these notes, please let me know.

GENERAL COMMENTS AND ISSUES

- 1. Docketing of Requested Documents and Other Items. Detroit Edison is currently providing reading room access only to several documents and other items requested in the RAIs. The NRC needs all requested documents and other items (with the possible exception of the 2006 site selection study), including those from the June 19 submittal and all future submittals, to be submitted by Detroit Edison for docketing. This is because all of these items will be cited as references in the Environmental Impact Statement (EIS); and all cited EIS references must be readily publicly available either in ADAMS or elsewhere. Randy Westmoreland stated that he will take this matter under advisement and discuss it with his management. Some of the items may be withheld only in the short term because they relate to the contentions. Steve Lemont stated that all requested documents and other items need to be submitted for docketing on or before December 30, 2009, in order to maintain the environmental review schedule; and that NRC would be amenable to further discussion on the matter, including discussions on a case-by-case basis. However, the bottom line is that the NRC will not be able to issue the Draft and Final EIS without all of these items being on the docket.
- 2. Modifications to Future RAI Response Submittal Schedule. NRC requested that Detroit Edison modify its future RAI response submittal schedule, on a monthly basis or as necessary, to include items identified in partial RAI responses that would be transmitted at a later date. (For example, the June 19 submittal indicated that the final aquatic monitoring report would be available by November 25, 2009, so that future submittal date should be included in the future submittal schedule submitted with the July 31 RAI response submittal.) This would greatly help NRC and Argonne in our tracking of RAI responses. It was also requested that Detroit Edison update its future submittal schedule monthly, as needed, to indicate any changes in response submittal dates. Randy Westmoreland stated that Detroit Edison can provide these schedule modifications.
- 3. <u>Future RAI Conference Calls.</u> Steve Lemont indicated that NRC and Detroit Edison should have RAI conference calls on an as needed basis, rather than a set schedule of bi-weekly calls as had originally been proposed. NRC and Argonne are developing a list of unanswered RAIs that we believe, for various reasons (e.g., complexity), we will need to discuss with Detroit Edison in advance of its responses to be sure Detroit Edison and its consultants are on the right track to providing what NRC needs. These would be among the subjects of future scheduled conference calls. The goal of this approach is to attempt to avoid the need for a second round of RAIs and associated schedule impacts. Of course, there can be conference calls held at any time to discuss questions Detroit Edison may have on the RAIs and any other matters pertaining to the environmental review. Detroit Edison agreed with this approach.
- 4. <u>Future Electronic File Transmittal Requests</u>. Steve Lemont asked if Detroit Edison could break future RAI response submittals into separate files (i.e., ones for the cover letter and each RAI response), and--in addition to providing four (4) copies of these on CDs to Steve Lemont--to upload them to Argonne's FTP site. This would greatly facilitate our handling of the RAI responses as they are received. Randy Westmoreland stated that breaking future submittals into separate files would be OK, but that he would have to discuss the matter of uploading files to Argonne's FTP site with his management and get back to us.

SPECIFIC COMMENTS ON JUNE 19 RAI RESPONSES

NRC's comments on specific RAI responses that were discussed are included in the attached table. This is a table in which NRC and Argonne are tracking the status of Detroit Edison's RAI responses in its June 19 submittal, and will be incorporated into NRC's overall project RAI response status table. The status tables are adapted from the original RAI table, with columns added for Response Date/ADAMS Accession Number, Status of Response (i.e., level of completeness), and Comments. Only RAI responses that were not deemed fully acceptable and complete were discussed during the call. NRC pointed out that many of these RAI-specific comments and issues could affect future RAI responses, and should therefore be considered accordingly by Detroit Edison in developing its future submittals.

ACTION ITEMS FOR DETROIT EDISON

- 1. <u>Docketing of Requested Documents and Other Items</u>. Randy Westmoreland will discuss with his management the matter of the NRC's requirement to submit all requested documents and other items for docketing; and will get back to NRC with a response or for further discussion. This applies to the June 19 submittal and all future submittals.
- 2. <u>Modifications to Future RAI Response Submittal Schedule</u>. Detroit Edison will provide the future RAI response schedule modifications as requested above.
- Future Electronic File Transmittal Requests. Detroit Edison will break future RAI response submittals into separate files, but Randy Westmoreland will discuss the matter of uploading these files to Argonne's FTP site with his management and get back to us.
- 4. Whereabouts of Dispersed SHPO Staff. Detroit Edison will seek information on the whereabouts of dispersed Michigan State Historic Preservation Office (SHPO) staff and provide that information to NRC. (NRC will look into this as well.)

Please contact me if you have any questions or need additional information. We look forward to receiving Detroit Edison's responses on the action items, and to receiving your future RAI response submittals.
