**Subject:** NEI 99-01, "Methodology for Development of Emergency Action Levels," Revision 5 Security Emergency Action Levels

Dear Mr. Miller:

The industry is required by regulation to implement 10CFR73.55 and 73.56 no later than March 31, 2010. This includes NRC endorsed NEI 03-12, "Template for Security Plan, Training & Qualification Plan". Security Emergency Action Levels (EALs) in NEI 99-01, "Methodology for Development of Emergency Action Levels," Revision 5, were revised to support NEI 03-12 implementation.

NEI 99-01, Revision 5, introduces Security EALs that differ from the Security EALs required by NRC Bulletin 2005-02, "Emergency Preparedness and Response Actions for Security Based Events". In addition, NEI 03-12 utilizes terminology that is not applicable to NRC Bulletin 2005-02 such as "Security Condition."

The industry is seeking clear understanding of the regulatory process for revising and implementing Security EALs from NEI 99-01, Revision 5, to support licensees Security Plan implementation of NEI 03-12.

NEI performed a comparison (Enclosure 2 - 4) between Security EALs based on NRC Bulletin 2005-02 (NUREG 0654, NEI 99-01, Revision 4 and NUMARC/NESP 007) and Security EALs contained

in NEI 99-01, Revision 5 and has drawn the conclusion that the intent of the Bulletin EALs are fully subsumed by NEI 99-01, Revision 5 EALs. Enclosure 1 provides a comparison of definitions used in NRC Bulletin 2005-02 and NEI 99-01, Revision 5.

This one-time review and endorsement by NRC for the use of NEI 99-01, Revision 5 EALs in support of NEI 03-12 implementation will reduce regulatory burden for licensees and NRC to make the necessary revisions to their EALs, without submission to the NRC for preapproval.
