Reference Task Order 1, Security Analysis of CPIC Screening Forms and Business Case Packages.

The purpose of this modification is to:

- 1) Exercise Option Year One of Task Order 1 (October 1, 2009 through September 30, 2010) in accordance with FAR Clause 52.217-9, Option to Extend the Term of the Contract, thereby extending the period of performance through September 30, 2010. The revised period of performance of Task Order 1 is from November 20, 2008 through September 30, 2010.
- 2) Increase the task order ceiling by \$98,709.36, from \$93,417.56 to \$192,126.92.

A letter providing preliminary written notification of the Government's intent to exercise Option Year One was emailed to KCG, Inc. on July 27, 2009.

This modification does not obligate any funding. Funding remains unchanged at \$93,417.56. These funds were previously transferred from Delivery Order NRC-DR-33-08-344 to Task Order 1. Additional funding will be added when it is available.
