The purpose of this modification is to (1) exercise Option Year One, and (2) increase the ceiling, as follows:

1) Exercise Option Year One (October 1, 2009 through September 30, 2010) in accordance with FAR Clause 52.217-9, Option to Extend the Term of the Contract, thereby extending the period of performance through September 30, 2010.

2) Increase the amount of the order (ceiling) by \$584,444.40, from \$559,045.60 to \$1,143,490.00. The amount of \$584,444.40 for Option Year One consists of estimated labor costs of \$576,944.40 and travel costs not-to-exceed \$7,500.00.

A letter providing preliminary written notification of the Government's intent to exercise Option Year One was emailed to KCG, Inc. on July 27, 2009.

Accordingly, Section A.2, Period of Performance, first two sentences, of the order is revised, as follows:

The period of performance of this delivery order is from October 1, 2008 through September 30, 2010. The term of this delivery order may be extended at the option of the Government for one additional one-year option period.

This modification does not obligate any funding. Funding will be placed on the individual task orders.

All other terms and conditions of the subject order remain unchanged.
