Charleston Area Medical Center would like to request that the CAMC Outpatient Imaging Center (OPIC) located at 3416 MacCorkle Avenue, S.E. Charleston, WV 25304 be added to the above referenced NRC License. The imaging center contains a PET/CT scanner that has been operating under WV Registration #200312 since July 26, 2006. The PET/CT imaging suite contains the scanner, control room, hot lab, injection room, two circulation rooms and a patient restroom as outlined on the included plans. The PET/CT suite is located on the ground floor as a single story addition with no workspace directly above or below. The North, West and South walls are outside walls bordered by alleyways and the interior walls are void of occupied workspace.
