For the public meeting, I have invited US Army Corps, SRBC, EPA. We also invited several agencies by letter, including FWS, PA DCNR, the Tribes, ACHP, NJ Natural Heritage Program, NOAA National Marine Fisheries Service, PA Fish and Boat Commission, PA Game Commission, Pennsylvania Historical & Museum Commission. SRBC plans to attend the meeting, US Army Corps does not plan to attend. Most of the other agencies probably will not attend but I don't normally get a confirmation from them.

For the audit, I have invited EPA, US Army Corps. It is also mentioned in letters to: ACHP, NJ Natural Heritage Program, FWS, NOAA National Marine Fisheries Service, PA Fish and Boat Commission, PA Game Commission, PA DCNR, Pennsylvania Historical & Museum Commission. We plan to also invite DEP to the audit. US Army Corps plans to attend the audit. I have not heard back from anyone else but we will contact the agencies that normally would attend (the PA agencies and FWS) with the new audit date. If anyone else that received a letter in the above list is interested, they will contact me.
