

The purpose of this modification is as follows:

- (1) To exercise Option Year One under the subject contract in accordance with FAR Clause 52.217-9 – Option to Extend the Term of the Contract. As a result, the ceiling amount of the contract is increased by \$105,664, from \$102,620 to \$208,284, and the obligated amount is increased by \$35,502, from \$96,000 to \$131,502. By exercising the first option year, the period of performance of the contract is extended through September 30, 2010.

Accordingly, the following section of the contract is hereby modified:

1. Under Paragraph B.2 - CONSIDERATION AND OBLIGATION, subparagraphs (1) and (3) are deleted in their entirety and replaced with the following:
 - (1) The total estimated cost to the Government for full performance under this contract is \$208,284.
 - (3) The amount presently obligated with respect to this order is **\$131,502**. The Contractor shall not be obligated to incur costs above this ceiling/obligated amount unless and until the Contracting Officer shall increase the amount obligated. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk.
2. Under Paragraph B.3 – DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 2, is hereby deleted in its entirety and substituted with the following:

This contract shall commence on October 1, 2008 and will expire on September 30, 2010. The term of this contract may be extended at the option of the Government for up to two additional one-year options as follows:

Option Year 1:	October 1, 2009 – September 30, 2010 (exercised)
Option Year 2:	October 1, 2010 – September 30, 2011

A summary of obligations from award date through the date of this action is given below:

Total FY09 Obligations.....	\$83,502
Cumulative Total of NRC Obligations.....	\$131,502

This modification obligates FY09 funds in the amount of \$35,502.

All other terms and conditions under this contract remain unchanged.
