Dear Mr. Heuter:

This letter is to confirm the verbal commitments made by General Dynamics Land Systems (GDLS) on July 23, 2009 (ref. b) regarding the following items:

1. *Building 105, Anniston Army Depot*: GDLS has never possessed or used byproduct material at this location; the location was added to the GDLS byproduct material license (item 10.B.) in anticipation of use of this building for storage and use of M88 ACADA (GID-3) units; this use of the building was never realized.
2. *Military Building 12, General Motors Proving Ground (item 10.A.)*: there has been no use of licensed material at this location since 1994; the only byproduct material used at this location consisted of M1 Infinity Collimators (Muzzle Reference Sensors) which incorporated sealed tritium sources and were a pre-installed component of M1 Tanks sent to this location on temporary, as-needed basis for operational and road testing; the sealed tritium sources in M1 Infinity Collimators were not subject to requirements for leak testing nor was the integrity of any of the units compromised at this location, surveys were therefore not necessary or performed at this location.
3. *Facility Name Amendments*: the facilities located at 6000 E. 17 Mile Road, Sterling Heights, MI (Logistics & Engineering Facility) and 38500 Mound Road, Sterling Heights, MI (Central Office) are amended to reflect only the changes to the names of the facilities; the operation of these facilities and the possession and use of byproducts at these facilities by GDLS continues as was authorized by license 21-21068-01, item 10.A.


