Betsy;

I apologize for the wording in Sec 2.2 of the FMC MARSSIM FSS report. The words "source material" was not a proper term of art to describe the use of building 22. The building was a temporary storage for low level radioactive material that was transferred to building 2 . No radiological work was conducted inside building 22.





To continue with our clients request to provide the most conservative approach to releasing the Site, RASI conducted a survey of building 22 yesterday to confirm the absence of any contamination. The survey is attached. The smear results range from 0-6 dpm/100cm2.

I would like to recommend that we change the verbiage in Section 2.2 to better reflect the Sites history.

To be clear, there was never any "source material" at FMC (uranium, thorium, etc). We are familiar with problems of source material buildup such as with water treatment facilities, etc. That was not the case at FMC.

Would a correction to the wording suffice?

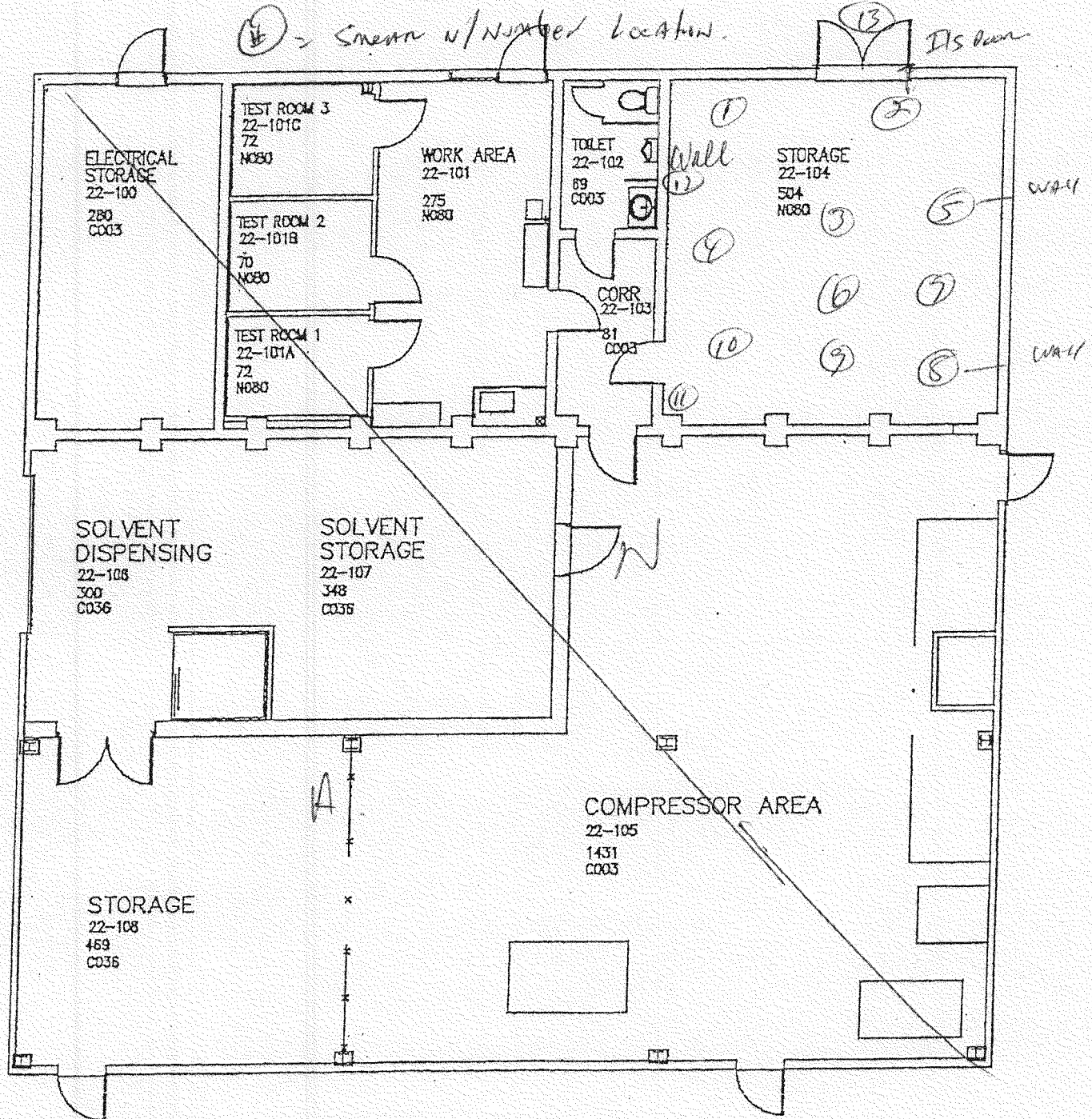
