You understand that upon the effective date of the Agreement between the NRC and the State of New Jersey, you will be licensed by the State of New Jersey to conduct work at temporary job sites in the State and as such, must file a NRC Form 241 (reciprocity) prior to performing any work in NRC jurisdictions (Non-Agreement States) or in areas of Exclusive Federal Jurisdiction within an Agreement State.
