The purpose of this modification is to:

1. Modify CLIN 001 to include the impact weather standard service maintenance, the impact weather interactive map maintenance and the weather bug GIS data service maintenance.
 - a. This will increase CLIN 001 ceiling for option period 4 by \$23,550 from \$575,243.76 to \$598,793.76.
 - b. This will also increase CLIN 001 for option period 5 by \$23,550 from \$438,970.94 to \$462,520.94. In addition,
2. Increase the obligated amount by \$129,000.00 from \$3,232,268.47 to \$3,361,268.47.

Accordingly the contract is modified as follows:

1. Section B.1.5 Entitled "Option Period Four (Year Four) – 1/1/2009-12/31/2009, CLIN 0001 is modified as follows:

2. Section B.1.6 Entitled "Option Period Five (Year Five) – 1/1/2010-09/30/2010, CLIN 0001 is modified as follows:

3. Section B.2., Consideration and Obligation – Firm Fixed Price (JUN 1988), is revised to read as follows:

"This clause applies to CLIN 0001 and corresponding option year CLIN 0001s, if exercised.

The firm fixed price of this contract for CLIN 0001 is \$122,127 for the base period; \$497,362 for Option Period One (Year One); \$528,390.61 for Option Period Two (Year Two); and \$554,434.46 for Option Period Three (Year three) and \$598,793.76 for option period 4 (Year Four). As stated under Section B.3 (a) of this contract, the amount presently obligated is \$3,361,268.47 of this amount \$2,301,107.83 is obligated for CLIN 0001."

4. Under Section B.3, Consideration and Obligation – Delivery Orders (JUN 1988), the first sentence of paragraphs (b) is revised to read as follows:

"(b) The amount presently obligated with respect to this contract is as follows: \$2,372,201.00. A breakdown is as follows:

CLIN 0002, 0003, 0004	\$1,060,160.64
TOTAL	\$3,361,268.47

All other contract terms and conditions remain unchanged.
