The purpose of this modification is to provide incremental funding in the amount of \$200,000.00 thereby increasing the total obligations from \$1,301,876.00 to \$1,501,876.00. Accordingly the contract is modified as follows:

"The amount obligated by the Government with respect to this task order is \$1,501,876.00 of which \$1,411,798.00 represents the estimated reimbursable costs, and the amount of \$90,078.00 represents the fixed fee."

All other terms and conditions remain the same including the Task Order ceiling of \$1,530,732.00.
