The purpose of this modification is to provide incremental funding in the amount of \$100,000.00 thereby increasing the total obligations from \$240,000.00 to \$340,000.00. Accordingly the contract is modified as follows:

"The amount obligated by the Government with respect to this task order is \$340,000.00 of which \$318,277.00 represents the estimated reimbursable costs, and the amount of \$21,723.00 represents the fixed fee."

All other terms and conditions remain the same including the contract ceiling of \$414,095.00.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
