The purpose of this modification is to increase the obligated amount by \$50,000 from \$1,985,000 to \$2,035,000. Accordingly, Paragraph (c) of Section B.3 entitled: "Consideration and Obligation - Cost plus fixed fee (JUN 1988) alternate I (JUN 1991) is revised to read as follows:

"(c) The amount presently obligated with respect to this contract is \$2,035,000 of which \$1,884,327.11 represents the estimated reimbursable costs and \$150,672.89 represents the fixed fee."

All other terms and conditions remain the same.
