

1. Section B. CONSIDERATION AND OBLIGATION—COST PLUS FIXED FEE (JUN 1988), paragraphs (a) and (c) are deleted in their entirety and replaced with the following:

- (a) The total estimated cost to the Government for full performance of this contract is \$100,672, of which the sum of [REDACTED] represents the estimated reimbursable costs, and of which [REDACTED] represents the fixed fee.

In the event that the Government exercises optional work pursuant to FAR Clause 52.217-8 and/or FAR Clause 52.217-9 incorporated in this task order, the total estimated amount of this order will increase as follows:
