To Whom It May Concern:

On October 1, 2008 Ground Breakers, Inc. a WV Corporation fully owned by John P. Keeley entered into a sale agreement with Pro Contracting, Inc. a WV Corporation owned by former employees of Ground Breakers Inc. After 30 years in the construction industry Mr. Keeley decided that he was ready to semi retire and pursue other interest. The sale of Ground Breakers, Inc. became a priority and finally ended in an asset sale to former employees who had opened Pro Contracting, Inc.

Pro Contracting, Inc. purchased the equipment, remaining materials, and uncompleted work load (with the exception of a few nearly completed jobs). Pro Contracting, Inc. employed the vast majority of the existing employees of Ground Breakers, Inc.

Pro Contracting, Inc. President is Bryan W. Reger, Mathew Evans is the Secretary and Chad Schaffer will be the contact/ Radiation Safety Officer, Chad was also the contact/RSO for Ground Breakers, Inc. All personnel having control over licensed activities with the exception of the above mentioned have not changed. Neither Dennis Elbon nor David Yazvac is employed by Pro Contracting.

The transferor, Ground Breakers, Inc. will remain in non-licensed business only long enough to complete two unfinished jobs both of which are expected to be completed by October 1, 2009.


The equipment storage, use, location, etc. will not change as Pro Contracting, Inc. is renting the same facility as was previously occupied by Ground Breakers, Inc. All storage procedures will continue to be employed by Pro Contracting, Inc.


The location of all records will not change and all records, calibrations, leak test surveys, inventories, and accountability are/will be current at the time of transfer.
