SUBJECT: SENIOR REACTOR AND REACTOR OPERATOR RETAKE EXAMINATION -
SEABROOK STATION

Dear Mr. St. Pierre:

In a telephone conversation on August 3, 2009, between Mr. Todd Fish, Sr. Operations Engineer/Chief Examiner, and Mr. Tim Cassidy, Training Support Supervisor, arrangements were made for the administration of the written retake licensing examination at Seabrook Station scheduled for October 1, 2009.

As agreed during the telephone conversation, your staff will prepare the examination based on the guidelines in NUREG-1021, "Operator Licensing Examination Standards for Power Reactors," Revision 9, Supplement 1. The NRC's regional office will discuss with your staff any changes that might be necessary before the examination is administered.

To meet the above schedule, it will be necessary for your staff to submit the written examination and the supporting reference materials identified in Attachment 3 of ES-201 by September 7, 2009. Pursuant to Title 10, Section 55.40(b) (3), of the Code of Federal Regulations (10 CFR 55.40(b) (3)), an authorized representative of the facility licensee shall approve the outlines and examination before they are submitted to the NRC for review and approval. All materials should be complete and ready-to-use. We request that any personal, proprietary, sensitive unclassified, or safeguards information in your response be contained in a separate enclosure and appropriately marked. Any delay in receiving the required examination and reference materials, or the submittal of inadequate or incomplete materials, may cause the examination to be rescheduled.

In order to conduct the requested written examination, it will be necessary for your staff to provide adequate space and accommodations in accordance with ES-402. Appendix E of NUREG-1021 contains a number of NRC policies and guidelines that will be in effect while the written examination is being administered.

To permit timely NRC review and evaluation, your staff should submit preliminary reactor operator and senior reactor operator license applications (Office of Management and Budget (OMB) approval number 3150-0090), medical certifications (OMB approval number 3150-0024), and waiver requests (OMB approval number 3150-0090) at least 30 days before the examination date. If the applications are not received at least 30 days before the examination date, a postponement may be necessary. Signed applications certifying that all training has been completed should be submitted at least 14 days before the first examination date.
