REMARKS: IMC 0308 Att 6 (Basis Document for Security Cornerstone of the Reactor Oversight Process) is issued to separate the basis for the security cornerstone from the rest of the Reactor Oversight Process (ROP) because of information sensitivity.

IMC 2201 (Security Inspection Program for Commercial Nuclear Power Reactors) has been revised to address recommendations from an Office of Inspector General's audit of the NRC's Security Baseline Inspection Program (OIG-06-A-21). It has also been revised to remove references to programs other than operating power reactors and to update terminology and format.

IMC 2201 App A (Security Baseline Inspection Program) has been revised to remove references to programs other than operating power reactors and to update program resource estimates.

IMC 2201 App B (Supplemental Inspection Program) has been revised to remove references to programs other than operating power reactors and to update terminology and format.

IMC 2201 App C (Generic, Special, and Infrequent Inspections) has been revised to remove references to programs other than operating power reactors and to update terminology and format.

IMC 2201 App D (Facility Status Reviews for Security and Safeguards Inspection Program) has been revised to remove references to programs other than operating power reactors and to update terminology and format. In addition, the title has been updated to be consistent with the title mentioned in IMC 2515, "Light-Water Reactor Inspection Program — Operations Phase. "

IP 93001, "OSHA Interface Activities," has been revised to add IMC 2503, "Construction Inspection Program: Inspections of Inspections, Tests, Analyses, and Acceptance Criteria (ITAAC)," and IMC 2504, "Construction Inspection Program - Non-ITAAC Inspections" to the program applicability section.
