**Subject:** 2009-07-15 ER RAIs requiring additional time and justification

Michael,

Here are some RAIs for which we believe it will take more than 30 days to provide a response. Per the original schedule, 30 day responses should be provided by July 27. We expect to provide complete responses to all the questions below within 45 days (by August 10) and some may be provided sooner.

SOC-15 (construction workforce), 18 (property taxes), and 23 (operations workers traffic): These items required additional information to be gathered by Luminant. This information was recently collected; however, it will require some additional time to prepare the responses.

SOC-04 (FM 56 turn lanes), 05 (local traffic data), and 16 (construction traffic): These items may require additional time based on the results of the existing traffic study. The existing traffic study information is currently being assessed. They are identified as needing additional time in the event that the existing traffic study is not sufficient to explain why additional traffic studies are not being performed by the state of Texas. Also, SOC-04 needs additional input from the state of Texas.

SOC-10 (local water treatment systems): This issue needs also requires input from the state of Texas. The information from the state is expected before the end of July. Once received, the issue can be worked.

HYD-18 and 19 (Lake Granbury heat balance): NRC is reviewing the heat balance report more thoroughly and may have additional clarifications regarding this issue.
