Mike,

We have a couple items to discuss:

- Follow-up Conference Call on Hydrology – We had a conference call on March 26, 2009, and as a result of that call, the reviewers were going to take a closer look at the Ward report and the CPNPP project was going to prepare a better explanation of Temperature, Flow, Total Deposited Solids (TDS), Thermal Stratification and Impacts to Aquatics on Lake Granbury During Low Flow and Winter Conditions. We said we would have a follow-up conference call in April (around the 17th). I would like to propose 1pm CDT/ 2pm EDT on Tuesday April 21 for the follow-up call.

- Traffic Studies – As a result of the site visit, the resolution of items SOC-01 and SOC-08 was related to the need for additional traffic studies. The NRC reviewers were going to check what was publicly available and the CPNPP project was going to research the need for additional studies. Again I suggest it is time to discuss this more. We are ready to present why we feel that additional studies are not needed. I suggest we discuss this topic during the conference call proposed above (Tuesday April 21, 2pm EDT)
- Reading Room - I assume that NRC reviewers are very interested in getting access to the documents that we agreed to make available in a reading room. We want these documents to be available to avoid unnecessary RAIs. We are ready to go. All we need are the terms and conditions from the NRC. Will the NRC's letter be coming soon? Although it would be more difficult and more expensive, we could look into setting up physical reading rooms. Do we need to start the process to set up physical reading rooms?

I understand from Stephen Monarque that you are out of town. Please respond when you get a chance.
