

The purpose of this modification is to 1) Exercise Task Area #3, providing off-site support for the NRC Administrative Services Center (ASC) at off-site headquarters locations, 2) Exercise Option Year 4 effective December 1, 2009 thru November 30, 2010, and 3) Increase the current contract ceiling by \$470,469.80 and add FY09 funding in the amount of \$28,272.00.

Details of the modification have been provided on Page 2.

- 1) The purpose of this modification is to Exercise Task Area #3 OFF-SITE SUPPORT FOR THE NRC ADMINISTRATIVE SERVICES CENTER (ASC) AT OFF-SITE HEADQUARTERS LOCATIONS, under the revised Statement of Work (SOW) dated November 30, 2007 through Modification 008. Task Area #3 provides support services at the Nuclear Regulatory Commission (NRC) One White Flint North (OWFN) Building in Rockville, Maryland for NRC's off-site headquarters locations. The services available from the designated location continuously throughout each federal workday (Monday-Friday, from 7:15am-5:00pm except federal holidays). The Contractor shall provide continuous coverage and support similar or abbreviated as described in Task Area 1 of this contract. Monthly and fiscal-year end report deliverables will be similar or abbreviated as described in this contract.
- 2) This modification hereby exercises Option Year Four effective December 1, 2009 thru November 30, 2010. Option Year 4 is hereby exercised in accordance with Section C.10 – FAR Clause – 52.217-9 Option to Extend the Term of the Contract (MAR 2000). As a result of this extension, Section C.20 Period of Performance is revised as follows:

"The term of this contract shall commence on March 15, 2006 and shall end on November 30, 2010. The period of performance may be extended for 0 years."

The effort associated with this option period is subject to FAR Clause 52.232-18 "Availability of Funds Clause".

- 3) This modification increases the current contract ceiling by \$470,469.80 from \$1,605,370.10 to \$2,075,839.90 and adds FY09 funds in the amount of \$28,272.00 increasing the amount presently obligated under this contract from \$1,601,806.00 to \$1,630,078.00. Section B.2 Consideration and Obligation – Firm Fixed Price (JUN 1988), is hereby deleted and substituted with the following:

- a. The firm fixed price of this contract for basic service is: \$2,004,990.40
- b. The total estimated amount for overtime under this contract is: \$ 70,849.50
- c. The amount presently obligated with respect to this contract is: \$1,630,078.00
